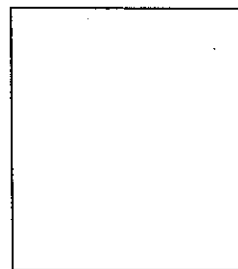

## RULES, TERMS AND CONDITIONS

1. The Management of TANJONG PUTERI GOLF RESORT BERHAD shall have sole responsibility for the management of the TANJONG PUTERI GOLF RESORT BERHAD and reserves the right to amend, vary, add to or formulate such rules, terms and conditions, including the withdrawal or addition benefits and privilege as in their absolute discretion deemed necessary.
2. A) All applicants must be at least 18 years old on the date of the application for membership. Children under the age of 16 years are not allowed to use the following facilities : SAUNA / GYMNASIUM / SNOOKER.  
B) Membership is not transferable and unless otherwise herein provided, membership fees and subscription fees are not transferable.
3. Membership cards are not transferable and will be honoured only when properly signed and presented by authorised member.
4. Members should advise The Management of TANJONG PUTERI GOLF RESORT BERHAD in writing immediately of any loss or theft of their membership card and also of any change of address, change of employer or any other information related to the membership application.
